4	<p>Cardiff Rugby Matters</p> <p>Meeting with Scott Waddington A meeting has been arranged with Scott Waddington for Friday at 1pm. Lynn and Karan did meet with him before the Munster match and introduced some of our key issues in that discussion. Some of the questions we need to ask are:</p> <ul style="list-style-type: none">- How does he see his role over the next few months.- Will he be involved in the sale?- Does he feed into recruitment?- What does he know and what can he tell us about the prospective buyers? <p>He may ask us about our meeting with the Hollywood Group. Our response should be that we would be happy to meet with anyone and to ask if it might be possible to arrange that with the other prospective buyers.</p> <p>Prospective buyers Lynn fed back on the meeting with the Hollywood bid team and also the informal meeting with them on match day. We haven't heard anything from them since the match, but the overall impression of the bid was favourable. The decision is due in the next few weeks, and we need to prepare for that. It is impossible to know what to say before a decision is made so we need to be ready for a quick response through our WhatsApp group and meeting at short notice. 6	<p>Cardiff Rugby Museum</p> <p>Sally fed back on latest display and heritage meeting last week:</p> <ul style="list-style-type: none"> - We reviewed the Lions display and lessons learnt - The new display celebrating our opposition has turned out better than expected. We will look to make further changes when the Six Nations begins. - Planning is now starting for the 150th displays and we hope to involve some of the local Cardiff clubs in this. - The Volunteer group has been a great help and are now taking on writing the programme pieces. - Derek has taken over the management of loans and will be coordinating this going forward - Issues of funding will be raised at the next Management Board.
